Updates & Open Discussion (KA & AL):

• Treasurer's Report

- o Recruitment: Up to 111 from 116 (stems from pre-K partnerships)
- o ACE Prep received the following grant dollars during the month of August:
 - Basic Grant=\$106,063.25 on 8.15.23
 - Title I=\$4,755.45 on 8.15.23
 - Part B (June)=\$3272.50 on 8.15.23
 - ESSER=\$2,856.87 on 8.15.23
 - Title I=\$2430.82 on 8.29.23

Board Participation in Recruitment

- o There is a need for the Board to continue to engage with Scholars and staff on a reoccurring basis
- Amanda and Kerriesha are currently looking at how other Charters are elevating their Boards for recruitment efforts
- o The Board discussed the following potential recruitment efforts:
 - Engage the Ace Prep staff to see where their interests are to leverage as recruitment efforts and/or other scholar engagement efforts
 - Engage the community via events at the school to raise awareness and visibility of Ace Prep, in addition to having the Board attend these engagement events
 - Elevate I-READ scores as they were strong in the 2022-23 school year
- o The Board will review the updated bylaws and language around the specific Committee roles and responsibilities to discuss in October (includes roles and responsibilities for recruitment and enrollment)
- o The Board will put together a preliminary template with activities where the Board can support in recruitment efforts
- o Mitch will meet with the MindTrust on areas for recruitment

COO & Principal Report (KA & AL):

- Hop, Skip, Drive: This is a transportation tool that the school has secured a one-year contract with
 - o Public transportation historically has not been a feasible option
- Fundraising Event: Aiming for one initiative a month
 - o Considering Read-a-Thon for 2023-24 school year but a new timing than years

- Scholar and Family Engagement: Will provide small incentive to Scholars with the best attendance
- Staffing: Updates have been implemented in alignment with Board feedback
- Academics: Having 2nd graders do IREAD to support remediation efforts
- Attendance: Attendance rate was above 90% every day
